- 1. Chairman's welcome.** The Chairman, Cllr Islwyn Iago, welcomed councillors and two representatives of the Penyparc Action Group to the meeting. The agenda was then discussed.

It was proposed by Cllr Ann Stokoe and seconded by Cllr Huw Lewis that the minutes of the January meeting were correct.
- 4. Declaration of personal interests:** Cllr. Auriol Williams (by letter)
- 5. Matters arising.**
Ceredigion Local Development Plan: Response to Council's request to extend consultation period of the Ceredigion Local Development Plan (2007-2022). **Application rejected by County Council.** Also Cllr Ann Stokoe's response to the draft prepared by the clerk. Further discussion was held between the two representatives of the Penyparc Action Group and the Councillors regarding the Cardigan Sand and Gravel issue. It was agreed that the Community Council forward a letter to the County Council noting the observations. The following resolution was proposed by Cllr Llinos Price and seconded by Cllr Des Davies "Ferwig Community Council supports the observations of the residents represented by the Action Group". All present were in favour.
The clerk was also asked to send the Council's observations regarding the 31 units suggested between the five wards (Ferwig, Gwbert, Llangoedmor, Llechryd and Penyparc). This is insufficient and it was felt that 50 units would be more realistic.
Blaenannerch Roundabout: Response to Council's complaint regarding traffic lights at Blaenannerch roundabout.
Community Toilets Grant Scheme: Response from Teifi Boating Club regarding the Scheme. Request received from Cllr Islwyn Iago to add the "Butterfly Farm" to list.
Dog Control Warning Signs: Response to Council's request for Dog control warning signs.
"No Through Road" Signs: Letter received from County Council regarding "No Through Road" sign at the entrance to Fferm y Bryn.
Gritting road from Gwbert to Penyparc: Response to Council's letter. The clerk was requested to send a further letter asking the County Council to consider distributing salt locally and also requesting further information regarding the legality of distribution. Information is also required of local contractors who may carry out the work.
