10. Other Matters:

- (a) **Penyparc Football Field:** The quotation of £1,365 + TAW received from Mr Gareth Owen for cutting the Penyparc Football field grass has been approved by Council.
- (b) **Site meeting** with the owner of the Cliff Hotel; Mr Nigel Nicholas, Mr Ian Dutch and Mr Eifion Jones (County Council officers); and Councillors Des Davies, Lyn Jones, Auriol Williams, Dilwyn Jenkins, Morris Davies, Haydn Lewis (County Council representative) and the Clerk to discuss matters of health and safety on the pathway leading from the hotel to the nearby beaches. The insurance company has concerns regarding potential hazardous incidents. A response is awaited from the County Council.
- (c) **Notices of Dog Mess dangers:** Following the receipt of samples supplied by the Clerk of Llangoedmor Community Council of designs created by school children of Ysgol Gymunedol Llechryd, it was agreed that the Clerk requests the staff and children of Ysgol Gymunedol Penyparc to consider designing similar bilingual posters to be used in locations in the community.
- (d) The Clerk was asked to contact the County Council regarding the following issues:
 - (i) The malfunctioning light near Cefnfor, Golf Club Lane, Gwbert;
 - (ii) Guttering near Blaenplwyf, Felinwynt;
 - (iii) Rubbish abandoned near Nantfach;
 - (iv) Gutter blocked near the upper entrance to Treprior Farm, Tremain;
 - (v) Potholes on the lane between Bolafron and Hafod Farm, Ferwig;
 - (vi) The 30mph sign on Penyparc square near the Heolyfelin estate has been vandalised;
 - (vii) Graffiti on the Blaenannerch roundabout;
 - (viii) Graffiti on the 30mph sign near Ystafell Berkley, Penyparc.
- (d) **Vehicle constantly parked on the pavement at Heol y Felin, Penyparc:** The Clerk was asked to contact the police as the vehicle causes potential hazard to pedestrians, pushchairs and wheelchair users.
