- 1. Chairperson's welcome.** The Chairman, Cllr Ann Stokoe, welcomed everyone to the April meeting.
- 2. Apologies for absence:** Councillors Islwyn Iago, Huw Jones.
- 3. Minutes of the previous meeting.**
It was proposed by Cllr Des Davies and seconded by Cllr Llinos Price that the minutes of the March meeting be recorded as correct.
- 4. Declaration of personal interests:** Cllr Dilwyn Jenkins (see item 6, Grants), Cllr Des Davies (see item 6, Grants), Cllr Auriol Williams (see item 6, Grants), Cllr Lyn Jones (see item 7, Planning).
- 5. Matters arising:**
 - (a) Deeds of Ystafell Berkley, Penyparc:** A response is awaited from the solicitor.
 - (b) Parking of vehicles at Patch:** A request is to be made for a site meeting with officers from the County Council.
 - (c) Item 9[200]: Boundary Commission for Wales:** The County Council recommends the following: That the western section of Ferwig (380 electors) be merged with the Cardigan wards thereby reducing the Penparc electorate to 1,472. Cardigan presently is divided into three wards (Mwldan, Teifi and Rhyd-y-fuwch); the recommendation will create an electorate of 3,477 to be sub-divided between the three councillors with an average of 1,159 electors in each ward. The recommendations were discussed by the Community Council and it was agreed to object to the merging of the western part of Ferwig with the Cardigan wards. The observations to be forwarded to the Commission by 19 April.

- (a) **Builders rubble:** Complaints have been received from members of the public regarding the rubble which obstructs pedestrians from using Evelyn’s Beach which is adjacent to the Cliff Hotel. The Clerk was asked to contact Mr Wells Jones, the proprietor of the Cliff Hotel to discuss the matter.
- (b) **Spreading of slurry:** A complaint has been received from a member of the public regarding the foul odours of slurry spreading by local agricultural contactors. The Clerk was asked to forward a sympathetic letter to the complainant.
- (c) **Tyres left at Pengarn:** It has come to the attention of the Council that used tyres have been left at Pengarn. The Clerk has contacted the County Council regarding this.
- (d) **Tree obstruction at Patch:** Complaints regarding the obstruction caused by the tree have been forwarded to Natural Resources Wales on a continuous timetable since August 2016. The Clerk was asked to complain to the authority at its lack of courtesy and total inefficiency dealing with this minor matter.
- (e) **Cllr T. Haydn Lewis (Local County Council member):** Cllr Lewis announced his retirement from the County Council on 4 May following a period of over forty years’ service for the various higher authorities; Cllr Lewis thanked the Community Council for the support shown him over the period.
