- 1. Chairperson's welcome.** The Chairperson, Cllr Auriol Williams, welcomed everyone to the July meeting. She wished Councillor Matthew Morgan well on his new venture.
- 2. Apologies for absence:** Cllr Des Davies, Cllr. Lyn Jones and Cllr. Llinos Price
- 3. Minutes of the previous meeting.**  
It was proposed by Cllr Dilwyn Jenkins and seconded by Cllr Peter Williams that the minutes of the June meeting be recorded as correct.
- 4. Declaration of personal interests:** None
- 5. Matters arising:**
  - (a) Path near to OC Davies Garage, Penyparc:** Cllr Llinos Price had informed the Council prior to the meeting that the path is uneven. It was decided that the Clerk would meet Cllr Price to see where the problem was and clarify whether it was a public footpath prior to deciding what steps to take.
  - (b) Naming roads:** Cllr Auriol Williams raised the issue that no names existed for the road from Penyparc to the junction with Ferwig and Mwnt, nor between the Chapel in Ferwig and Heolcwn. It was agreed that it would be good to name these roads and also the square where the junctions for Penyparc, Mwnt Road, Ferwig and Verwig Road meet. The clerk will make enquiries with Steffan Jones at the County Council.
  - (c) Representation of the Minor Authorities on Government Bodies:** A new representative needs to be nominated for Ysgol Penyparc's Government Body as Cllr Eurig Lloyd's term has come to an end. Cllr Dilwyn Jenkins proposed that Cllr Eurig Lloyd be re-instated, this was seconded by Cllr Lloyd Jenkins.
  - (d) Welsh Water:** a complaint has been received that the land at Nyth y Wennol in Penyparc has been flooded for the third time this year following a burst pipe. The clerk will write to Welsh Water to communicate the complaint and ask for a response.
  - (e) Drones:** It was mentioned that drone flew above Ysgol Penyparc soon after the sports day and a helicopter flew over during the sports day. Cllr Clive Davies will work with the new Headteacher when he begins his post.
  - (f) Pillar near to the Gwbert viewpoint:** a pillar and plaque at the top of the land near the viewpoint has been damaged following a car accident. It was advised that the County Council is responsible for this and the Clerk will inform the appropriate officer.

## **10. Other Matters:**

- (a) **Cardigan Health Centre:** Following the Health Centre's response, a copy of the letter to the Health Centre will be sent to Jill Patterson at Hywel Dda Health Board.
- (b) **Councillor Vacancy:** Advertisement has been submitted to Y Gambo and an official new name is hoped for by September.
- (c) **Bryn Teg:** Cllr Clive Davies had sent a letter to the owner. The owner responded verbally stating that he was happy for the Council to put the monument back in place. It was decided that a letter would be written to Mr Bell with the intention of appointing a contractor to do the work. Clerk will contact the contractor to confirm a quote.
- (d) **Planning Application A190149:** This has been passed on the condition that a fence of the appropriate height is raised.
- (e) **Porth y Gymuned:** It was agreed that Carys Owen would attend the September meeting at 7pm.
- (f) **Hywel Dda Health Board:** Reading material has been distributed to Councillors with regard to the Interim Trauma Unit in Glangwili Hospital.
- (g) **Streetlights:** It was agreed that a sign would be placed on Ferwig and Penyparc noticeboards so that the area's inhabitants know where to contact regarding deficient street lights.

## **11. County Councillor's Report – Cllr Clive Davies:**

- (a) **Clun Bach:** Application plan has been approved.
- (b) **Application 190255:** An objection has been received noting that the site applied for is in front of the objector's house.
- (c) **Place Plans:** Had a meeting with consultants to discuss this. Questionnaires need to be collated for analysis.
- (d) **Yellow Lines:** The Council has stated that there isn't enough justification for painting yellow lines in Penyparc. And it won't be possible to discuss it until 2021.
- (e) **Patch Area:** A meeting was held with the marine Group and Bay to Remember in Patch in the hope of moving forward to long term developments in the area. A very positive meeting was held.
- (f) **LoRaWan:** An explanation was provided as to this project's development in Llechryd and the Council was asked for possible ideas on how it could benefit Penyparc. A meeting was held between Cllr Clive Davies, Richard (student) and an officer from Welsh Government to discuss this project. He will be meeting with police and Arwyn from the County Council soon to discuss developments.
- (g) **Welsh Water:** He mentioned the recent problem of a burst pipe at Ystafell Berkley. The problem started on the plot next door.

- (h) **LDP:** he asked had anyone considered application sites for the Local Development Plan. This needs to be discussed further. A full picture of the whole area will be needed by September.
- (i) **Climate Emergency:** The County Council has declared a Climate Emergency. It has a CO2 neutral plan to achieve by 2023. This will mean encouraging more renewable energy, electric cars and better energy efficiency in schools.
