a) **Cerflyn yn Mwnt/Mwnt Sculpture – Braf clywed bod y cerflyn wedi cael i dychwelid i Mwnt ac eu bod wedi cael i osod ar ben rhewl Ffynnon grog. Siomedig clywed bod y ymddiriedolaeth genedlaethol heb fod mewn cysylltiad.** *Great to hear that the sculpture had been returned to Mwnt and has been erected on the end of Ffynnon grog lane, but it is disappointing to note that the National Trust has not been in contact regarding the mater.*

b) **Gwaith ar wyneb Golygfaf Gwburt/Work done on the surface of Gwburt Viewpoint – Mae'r Cyngor Sir wedi gwneud rhywfaint o waith atgyweirio ar yr wyneb, ond nid yw'r safon yn dda iawn ac yn sicr mae'n dasg glytiog ac ni fydd yn para'n hir. Mae hyn yn siomedig iawn gan eu bod wedi addo yn y cyfarfod a gynhaliwyd yn Ysgol Uwchradd Aberteifi, y byddau'r cyfan cael ei atgyweirio eleni. Fydd Cyng Clive Davies yn gofyn am ddiweddariad ar y mater.** *The County Council have carried out some repair work at the surface, but the standard is not very good and it is certainly a patch job and will not last very long. This is very disappointing as they had promised in the meeting held at Cardigan Secondary school, that the whole surface would be done this year. Cllr Clive Davies to ask for an update on the mater.*

- (a) **Carafan yn Penparc – Mae trigolion lleol wedi mynegi pryder eto ynglŷn â'r garafán ar ffordd Heol y Felin a'i bod yn cael ei hysbysebu fel clerch 'Air B&B' i holi gyda gorfodaeth cynllunio am gyfreithlondeb carafán ar eich eiddo.** *Residents have again expressed concern regarding the caravan on Heol y Felin road and that it is being advertised as an 'Air B&B' clerk to enquire with planning enforcement the legalities of a caravan on your property.*
- (b) **Carreg Cofeb yn Gwbert/memory stone in Gwbert – Mae teulu lleol yn gofyn am gymorth gyda charreg cofeb y mae nhw wedi ei gosod yn y golygfan. Oes rhywun wedi ei weld? Clerc wedi rhoi post ar gyfryngau cymdeithasol yn ddiwerth.** *A local family are asking for help as regards to a memory stone they have placed at the viewpoint. Has anyone seen it? Clerk has put out a post on social media to no avail.*
- (c) **Cardi Bach – Ydy hi'n dychwelyd y tymor hwn? Nid yw'n debyg, sy'n siomedig iawn. Dywedodd y Cyng Clive Davies fod Dolen yn cymryd drosodd rhai gwasanaethau ond bod toriadau mawr wedi bod i holl drafnidiaeth y sir. Gwelir sawl toriad ar y gwasanaeth T5. Mae angen rhoi adborth i Traws Cymru, y clerch i adrodd.** *Is it returning this season? Apparently not, which is very disappointing. Cllr Clive Davies reported that Dolen are taking over some services but there have been major cutbacks to all transport across the county. Several cutbacks are seen on the T5 service. Feedback needs to be given to Traws Cymru, clerk to report.*

Cllr Davies reassured everyone that the plan is still in place but there is a lack of funding to carry out the work at present. He will again send a letter expressing the councils concerns.*
