- Plans for Gwyl Fach Aberporth going well. Attended the monthly meeting
- Supported the Mermaid Race along the estuary, including the Dyffryn Team in the race.
- Meeting regarding the Economic strategy for Ceredigion and Powys with Cabinet Member in Powys
- Discussion with Welsh Water on issues with Aberporth monitoring. Asking for real time monitoring.
“In terms of Aberporth, DCWW do not have a water quality model and unfortunately, no coastal investigation either currently. We are reviewing with NRW which bathing waters need investigations to understand more about them classifications and Aberporth is being considered in this. Ive added the status trend below just for info; I also spoke with the local NRW Senior Environment Officer who advised that Ceredigion County Council (Environmental Health Officers) have been doing a lot of work around misconnections in the area at Aberporth. I’m hoping to check in with local networks teams to see if we can offer any support with this investigation too. “
- Welsh Water meeting on the new Cardigan Sewerage Treatment facility which will take Gwbert waste. Sing post query by residents to community engagement officer at Dwr Cymru
- Chaired the Economic partnership meeting, several grant support decisions made including businesses in Cardigan.
- Attended opening of Bridal shop in Cardigan which received Government funding to support building work.
- Attended meeting with Minister Julie James at Guildhall which received Government funding for building work.
- Provided an overview of area and visited some businesses in Cardigan with 5 EU Diplomats from France, Germany, Poland, England and Netherlands.
- Arrange meeting with regional representatives on the Welsh Government cuts for bus provision in Ward, now with even further reduction with T5 bypassing Aberporth.
- Correspondence with Welsh Government Trunk road to get timescale if possible for footway from Penparc to Cardigan. All work at planning done, down to budget. Meeting arranged to discuss further on 5th June.
- Discuss with officers on toilet provision in Cardigan – grant application and signing off changing spaces, new toilet in Aberporth. Also start discussion around development of Pen yr Odyn in its entirety, scoping meeting being arranged with stakeholders.
- Update meeting with school build project in Aberporth with officers, progressing well, curtain wall work and addition of lift. Almost a million invested in total.
- Penparc School, long-term investment in building an extension agreed at Cabinet along with a number of other schools in county.
- Viewpoint Car park Gwbert - No plans to fully tarmac the car park in short term. Officers considering idea to invest with trading space potential to cover cost and viability of the area of land and resurface.
