Archwiliad mewnol gan Mr Ken Griffiths ac archwiliad allanol 2023-24.

Dosbarthwyd cyfrifon y Cyngor ac adroddiad Mr Ken Griffiths i pawb cyn y cyfarfod. Prif awgrimiadau'r adroddiad i'w drafod – prisiadau ar y rhestr asedau ac yswiriant y Cyngor i cynnwys diffibrilwyr sydd wedi cael i archebu.

Internal audit by Mr Ken Griffiths and the external audit for 2023-24

A copy of the council accounts and internal audit report from Mr Ken Griffiths were distributed before the meeting. The main recommendations of the report to be discussed are – the valuations on the asset list and the inclusion of the defibrillators purchased on the asset list and insurance policy.

Cafwyd trafodaeth ar y Diffibrilwyr a'r meinciau a brynwyd yn ddiweddar. Cytunwyd y dylid eu rhoi i gyd ar y rhestr Asedau a'i diweddaru ar gyfer y flwyddyn 2024/25. Roedd y Clerc wedi cysylltu â'r cwmni yswiriant yn flaenorol ynglŷn â'r diffibrilwyr ac wedi cael gwybod y byddai tâl ychwanegol o £21 y defib y flwyddyn. Roedd y cleric hefyd wedi holi Cyngor Aberteifi a oeddent wedi yswirio eu diffibrilwyr ac wedi cael gwybod nad oeddent yn eu heitemeiddio ar eu yswiriant. Penderfynwyd peidio ag yswirio'r diffibrilwyr yn unigol oni bai bod problem yn codi yn y dyfodol.

A discussion was held on the Defibrillators and benches that have recently been purchased. It was agreed that they should all be placed on the Asset list and for it to be updated for the year 2024/25. The Clerk had previously contacted the insurance company regarding the defibrillators and had been advised that there would be an additional charge of £21 per defib per year. The clerk had also enquired with Cardigan Council as to whether

they had insured their defibrillators and had been advised that they did not itemise them on their insurance. It was decided not to individually insure the defibrillators unless a problem arose in the future.
