1. **Croeso'r Cadeirydd / *Chairperson's welcome***: Croesawodd yr Is-Cadeirydd, y Cyng. Lyn Jones, pawb i'r cyfarfod ar ôl toriad yr haf. Croesawodd aelodau o'r cyhoedd ac aelodau o'r Clwb Golff i'r cyfarfod a gofynwyd y neu tro i rhoi eu barn am Cais Cynllunio A240567 i'r Cynghorwyr. Mr Barry Davies Cadeirydd y Clwb Golf a Mr Peter Merryweather. Diolchwyd i'r Cyngor am y cyfle i egluro'r datblygiad, a esboniwyd bod Clwb Golff Aberteifi yn glwb llwyddiannus iawn a gafodd gefnogaeth golff Cymru wedi ennill llawer o wobrau yn ddiweddar. Eglurodd y prif egwyddor y tu ôl i agor y maes parcio i'r golff er mwyn caniatáu parcio i 5/6 o geir. Mae'r cyfleuster hwn ar gael i bawb ond mae'n arbennig o ddefnyddiol i aelodau hŷn ac iau y Clwb. Mae'n caniatáu i aelodau iau ymarfer taro'r bêl ayyb, ond gan ei fod yn dipyn o ffordd o'r prif dŷ clwb, mae'n golygu bod rhaid cerdded ar draws y cwrs cyfan i'w gyrraedd. Ychydig o fygis sydd ar gael ar y safle iddynt eu defnyddio ar gyfer y cyfleuster hwn. Y syniad yw bod ar e.e. Bore Sadwrn byddai rhieni yn gallu gollwng aelodau iau yn y maes ymarfer er mwyn iddynt gael gwersi penodol yn yr ardal honno. Byddai angen eu casglu oddi yno wedyn. Ceisiwyd cynllunio yn flaenorol ar gyfer mynediad i'r ardal honno i adeiladu'r siediau ac ar gyfer cynnal a chadw. Ar hyn o bryd nid oes mynediad cyhoeddus i'r ardal honno. Wrth ddatblygu'r maes parcio, byddai mynediad trwy gerdyn/cod allwedd yn unig i aelodau'r clwb ac nid i'r cyhoedd.

*The vice-chairperson Cllr. Lyn Jones welcomed everyone to the meeting which included members of the public and the Golf Club who wished to express their opinions to planning application A240 567. They were asked in turn to give their viewpoints to the Councillors.*

*Mr Barry Davies Chairman and Mr Peter Merryweather of Cardigan Golf Club - thanked the council for the opportunity to explain the development, they explained that Cardigan Golf club was a very successful club that had the support of the Golf Development Wales having won many awards recently. He explained the main principle behind the opening of the golfing range to allow for parking for 5/6 cars. This facility is available to all but is particularly useful to the older and younger members of the Club. It allows younger members to practice hitting the ball etc, but as it is quite a way from the main club house, it means that they must walk across the whole course to get to it. There are limited buggies available on site to them to use for this facility. The idea is that on a, for example. Saturday Morning parents would be able to drop off younger members at the driving range for them to have specific lessons in that area. They would then need to be collected from there. Planning had been sought previously for access to that area to build the sheds for the range and for maintenance etc. Currently there is no public access to that area. In developing the parking area, it would be by card/key code access only for members of the club and not for the public.*

**Mynegodd Mr Huw Jones a Ms Anna Nicholls eu pryderon fel trigolion Ffordd Waungaelod a pherchnogion eiddo cyfagos.** Roedd eu prif bryderon yn ymwneud â'r lôn gul sy'n arwain at y maes chwarae sydd â dim ond 2 le pasio ar hyn o bryd sydd ill dau yn eiddo preifat. Mae perchennog y safle wedi nodi y bydd yn cau'r ddau fan pasio os rhoddir caniatâd cynllunio. Dim ond unwaith y flwyddyn y caiff y gwrychoedd eu torri, ac ar brydiau, gallant fod wedi tyfu'n wyllt. Mae'r porth sydd yno ar hyn o bryd ar gyfer cynnal a chadw wedi ei osod yn ôl ac eisoes yn achosi rhai problemau gyda phobl yn parcio yno i ddefnyddio'r maes golff, ac yna'n rhwystro mynediad i'r eiddo ar ddiwedd y ffordd - sef ffordd dim trwodd. Y disgwyl yw y byddai cynnydd yn nifer y ceir drwy ddatblygu'r maes parcio, ac o'r blaen ni fyddai'r lôn yn gallu ymdopi â'r cynnydd hwn a dim digon o le i dynnu i mewn. Mae hefyd yn ffordd serth sy'n ei gwneud yn her i wrthdroi pan fo angen. Mae nifer o wrthwynebiadau hefyd wedi eu cyflwyno ar borth Ceisiadau Cynllunio Ceredigion i ddangos barn nifer o drigolion sy'n defnyddio'r ffordd honno.

and nearby property owners. Their main concerns were regarding the narrow lane leading up to the driving range which currently has only 2 passing places which are both privately owned. The owner of which has indicated that he will close both passing places if the planning application is given consent. The hedges are only cut once a year, and at times, can be very overgrown. The gateway that is currently there for maintenance is set back and is already causing some problems with people parking there to use the range, and then blocking access to the property at the end of the road – which is a no through road. The expectation is that there would be a rise in car numbers by developing the parking area, and therefore the lane would not be able to cope with this increase and insufficient room to pull in. It is also a steep road which makes it a challenge to reverse when needed. Several objections have also been placed on the Ceredigion Planning Applications portal to show the views of residents that use that road.
