- 1. Croeso'r Cadeirydd / *Chairperson's welcome*: Croesawodd y Cadeirydd, y Cyng. Dilwyn Jenkins, pawb i gyfarfod olaf o'r flwyddyn gan estyn croeso cynnes i aelod or cyhoedd.**
The chairperson Cllr. Dilwyn Jenkins, welcomed everyone to the last meeting of 2024, and he also extended a welcome a member of the public.
- 2. Ymddiheuriadau am absenoldeb / *Apologies for absence*: Cyng. / Cllr Lloyd Jenkins**
- 3. Cofnodion y cyfarfod cyffredinol blaenorol / *Minutes of the previous meeting*: Cynigwyd gan y Cyng. Melanie Davies ac eilwyd gan y Cyng. Auriol Williams bod cofnodion mis Tachwedd yn gywir.**
It was proposed by Cllr. Melanie Davies and seconded by Cllr. Auriol Williams that the minutes for the November meeting be recorded as correct
- 4. Datgelu buddiannau personol/ *Declaration of personal interests*: Dim / None**
- 5. Materion yn codi / *Matters arising*:**
 - a) Cwrdd ar adran estates am golygfan Gwberrt/Meeting with the estates department regarding the Viewpoint.** Siomedig iawn bod y Cyngor Sir heb cadw at ei addewid o gwneud y gwelliannau i'r golygfan fel sydd wedi ei gosod yn y contract ac sydd hefyd wedi cael i addo ar lafar . Maent heb edrych ar ol y darn o dir o gwbl, sydd yn poblogaidd iawn gan aelodau o'r cyhoedd. Fydd yna cyfarfod ar 'Teams' ar y 12 o Chwefror i'w drafod ac edrych am ffordd ymlaen. *It is very disappointing that the County Council has let the Community council down in such a way by not following what was in the contract and also breaking promises made in person to Councillors – they have not looked after and maintained the very popular viewpoint. This will have to be discussed via a 'teams' meeting on the 12 February to plan a way forward for the area.*
 - b) Cinio Nadolig Yr Henoed – Mae yna tua 63 yn mynychu y cinio yfory gyda y Ficer Wyn Maskell yn dod i ganu carolau.** Croeso cynnes i aelodau o'r Cyngor hefyd i mynychu. *There are 63 people attending the Christmas lunch tomorrow with Vicar Wyn attending to play the organ and sing carols with residents. There is a warm welcome for all the Councillors to attend.*
 - c) Coeden Nadolig yn Ferwig a Penparc – Ar ôl cwrdd lan dydd Sul mae 2 lleoliad wedi ei dewis – sgwar isaf Penparc a sgwar Granwen yn Ferwig.** Mae Y Cyng Gethin Davies a Dilwyn Jenkins yn mynd i fynd ati wythnos yma i baratoi y safleoedd cyn gosod y coed diwedd yr wythnos. *After a site meeting on Sunday, Sgwar isaf Penaprc and Garnwen Junction have been decided as the 2 locations for the Christmas trees. Cllr. Gethin Davies & Dilwyn Jenkins have volunteered to prepare the sites before the trees can be put up at the end of the week.*
 - d) Gwaith ger Trecefen/Bettel – Mae'r Cyng Clive Davies wedi codi y cwestiwn yng nghlyn ar bwlch ac ati gyda'r Cyngor Sir ac ar hyn o bryd mae yn aros am ymateb.** *Cllr Clive Davies has raised the concerns with the enforcement department and is waiting for further information.*
 - e) Cae Chwrae Ferwig – Roedd y Clerc wedi cwrdd a cael dyfyniad wrth cwmni arall – RTC Safety surfaces am y gwaith yn y cae chware – sydd tipyn yn rhatach na'r dyfyniad wrth Adventure Playgroud.** Cynigiwyd gan Y Cyng Melanie Davies ac ailwyd gan Y Cyng Lyn Jones i'r gwaith cael eu cwblhau gan RTC safety surfaces. Cytunwyd hefyd i Neil Morris o Teifi Landscaping i cwblhau y gwaith o torri nol ar y tyddiant o gwmpas fense yn y cae chware. *The clerk has received another*

quote for the work to be completed at the play area from RTC Safety Surfaces – this is some £1500 cheaper than Adventure Playgrounds with the same terms/work to be done. It was proposed by Cllr. Lyn Jones & Seconded by Cllr. Melanie Davies to go with this quote. It was also agreed that Mr Neil Morris of Teifi Landscaping cut back on all the growth around the fence etc to tidy the whole playground up for the spring. The work will hopefully be completed in January.

- f) **Cyfarfod rhwng Cyngor Sir Ceredigion a Cyngorau cymunedol – Cynhaliwyd cyfarfod llawn gwybodaeth yn yr ysgol fis diwethaf gydag amrywiaeth o bynciau o bob rhan o'r ardal. Y prif bynciau dan sylw oedd toiledau gyda rhai Cyngorau Cymuned bellach yn gorfod cymryd drosodd toiledau pentrefi ar gost sylweddol iddynt eu hunain; casglu sbwriel a'r problemau sy'n gysylltiedig ag ef a'r broblem o ddŵr a chwteri/draeniau ddim yn cael eu clirio ac achosi llifogydd lleol. Mewn perthynas â Ferwig/Gwbert yn benodol gofynnodd y Cyng. Dilwyn Jenkins y cwestiwn ynglŷn â'r Pontŵn yn Patch a'r posibilrwydd o ddatblygu a chwistrellu arian yn y maes hwn yn y dyfodol. Bu peth trafodaeth ar y mater, ond dywedwyd wrtho y bydd ymateb swyddogol ar y mater yn cael ei roi yn fuan.** *An informative meeting was held last month at the school with a range of topics covered from across the area. The main topics covered were toilets with some Community councils now having to take over village toilets at a significant cost to themselves; rubbish collection and the problems associated with it and the problem of water and gutters/drains not being cleared and causing localised flooding. In relation to Ferwig/Gwbert specifically Cllr Dilwyn Jenkins asked the question regarding the Pontoon in Patch and the possible development and injection of n money in this area in the future. There was some discussion on the matter, but he was told that an official response on the matter will be given soon.*

Ysgol Feithrin Penparc – trafodwyd y cais gan eu bod angen arian ar frys tuag at adnoddau i disgybl newydd sydd yn yr ysgol. Cytunwyd bod angen 'wish list' o'r adnoddau pwysicaf erbyn y cyfarfod nesaf. *This request was discussed as the Ysgol Feithrin requires additional funding for a new pupil with specific educational needs. It was agreed to ask the Feithrin for a 'wish list' of the most urgent resources needed by the next meeting.*

7. **Cynllunio/Planning:**

Gwyro llwybr cyhoeddus er Fferm y Graig, Mwnt - Public Path Order near Graig Farm, Mwnt

Mae cais wedi ei wneud gan dirfeddiannwr lleol, Mr Ken Griffiths i ailgyfeirio'r llwybr cyhoeddus rhag mynd trwy ei fferm ac i ddilyn ffin y cae ac ail ymuno â'r llwybr troed presennol ar y ffordd Mwnt i Felinwynt. Byddai hyn yn gwneud y llwybr troed rhyw 50m yn hirach a byddai angen ei ffensiō ac ati a fyddai'n dod ar gost ychwanegol i Mr Griffiths. Roedd Mr Griffiths yn bresennol yng nghyfarfod y Cyngor i egluro ei resymau dros y cais. Diogelwch yw'r prif bryder gydag anifeiliaid a pheiriannau'n mynd yn fwy ac yn fwy peryglus gyda phobl yn cerdded drwy'r iard. Yn ystod y blynyddoedd diwethaf bu problemau niferus gyda phobl yn gadael giatiaiau ar agor; cerdded yn hwyr yn y nos; gadael tapiau dŵr ymlaen ac ati. Cynigwyd gan y Cyng. Lyn Jones ac eiliwyd gan y Cyng. Melanie Davies y dylid cefnogi symud y llwybr a chytunwyd ar hyn yn unfrydol gan yr holl gynghorwyr.

An application has been made by a local landowner, Mr Ken Griffiths to redirect the public footpath from going through his farm to follow the field boundary and rejoin the current footpath on the Mwnt to Felinwynt road. This would make the footpath some 50m longer and would be required to be fenced etc which would come at an additional cost to Mr Griffiths. Mr Griffiths attended the council meeting to explain his reasoning behind the request. Safety is of the main concern with animals and machinery becoming bigger and more dangerous with people walking through the yard. In recent years there have been numerous problems with people leaving gates open; walking late at night; leaving water taps on etc. It was proposed by Cllr. Lyn Jones & seconded by Cllr. Melanie Davies that the path move be supported and this was unanimously agreed by all councillors.

It was agreed that standards and safety are important, and that everyone must note the comments and guidelines of the NRW, trunk road agency etc. It is also important that the lagoon is monitored closely for problems as these developments are new in the area. It was decided to send a letter to the planning department stating these concerns about the importance of everyone's safety.</i>
