- 1. Croeso'r Cadeirydd / Chairperson's welcome:** Croesawodd y cadeirydd y Cyng. Dilwyn Jenkins, bawb i'r cyfarfod gan obeithio bod pawb wedi cael Nadolig a blwyddyn newydd braf. Dymunodd iechyd da i bawb ar gyfer 2025. Mynegodd ei gydymdeimlad â'r holl deuluoedd oedd wedi colli anwyliaid yn ddiweddar ac yn enwedig yr adeg hon o'r flwyddyn. Yn anffodus mae dau gyn gynghorydd Ferwig wedi marw dros y cyfnod. Bu Dewi Thomas (Pentre) yn gynghorydd am ryw 3 blynedd ar ddiwedd y 1990au. Hayden Lewis oedd Cadeirydd cyntaf y cyngor cymuned yn 1974 – cyn hynny roedd yn gyngor plwyf. Bu wedyn yn Gynghorydd Sir am nifer o flynyddoedd, yn gyntaf gyda Dyfed ac yna gyda Cheredigion. Roedd yn gyn-Gadeirydd Cyngor Sir Ceredigion yn ogystal â Heddlu Dyfed Powys. Bydd colled fawr ar ei ôl gan y gymuned ond yn anffodus roedd wedi dioddef afiechyd yn y blynyddoedd diwethaf. Cynhaliodd y Cyngor funud o dawelwch mewn parch tuag ato.  
The chairperson Cllr. Dilwyn Jenkins, welcomed everyone to the meeting and hoped that everyone had had a restful Christmas and new year. He wished everyone good health for 2025. He expressed his sympathy to all families who had lost loved ones recently and especially at this time of year. There are two past Councillors of Ferwig who had sadly passed away over the period. Dewi Thomas (Pentre) was a councillor for some 3 years in the late 1990'ies. Hayden Lewis was the first Chairman of the community council in 1974 – before that time it was a local council. He then became a County Councillor for several years, firstly with Dyfed and then with Ceredigion. He was a past Chairman of Ceredigion County Council as well as for Dyfed Powys Police. He will be sadly missed by the community but unfortunately had suffered ill health in recent years. The Council held a one minutes silence as a mark of respect.

- *Inquiring about the timing of the bridging fund offer letter from the UK Government, since received an outline of the fund. Ceredigion is to receive a cut of 42% rather than 40% because Welsh Government intervention on prioritizing the South Wales Valleys will receive the 2% extra.*
- *It was reported that drainage was broken in the Ferwig area and potholes in the roads in Aber-porth*
- *The road markings reported under any traffic order were not agreed.*
- *The proposal to create an enforcement team to support the growing misuse of planning across the county was discussed.*
- *Compile a spreadsheet of estimated costs for clerks across the area to work on for around a year bridging for the provision of public toilets.*
- *The BBC's investigation into a proposal for a change in the law for neglected cemeteries to be the responsibility of local authorities with no additional budget to support them.*
